(First Request)

17 Defendant, Las Vegas Metropolitan Police Department (“LVMPD”), by and through its
 18 counsel, Kaempfer Crowell, and Plaintiff, Go Best, LLC (“Plaintiff”), by and through its
 19 counsel, Ashcraft & Barr, hereby respectfully submit this Stipulation, Request and Order
 20 Extending Time to Answer or Otherwise Respond to Plaintiff’s Complaint (the “Stipulation”).
 21 This Stipulation is made in accordance with LR IA 6-1 and LR IA 6-2 of the Local Rules of this
 22 Court. This is the first request for an extension of time to file an answer or otherwise respond to
 23 Plaintiff’s Complaint.

1 Plaintiff filed its Complaint on April 1, 2024, [ECF No. 1], and LVMPD was served
