**Stipulation to Extend United States'  
Deadline to File Response to Plaintiff's  
Complaint**

**(First Request)**

17 Plaintiff, Bo Zhang, through counsel and the United States of America on behalf of  
18 Federal Defendants, through undersigned counsel, hereby stipulate and agree as follows:

- 19 1. Plaintiff filed the Complaint on November 18, 2024 (ECF No. 1).  
20 2. Plaintiff served the United States with a copy of the Summons and  
21 Complaint on November 20, 2024.  
22 3. The current deadline for the United States to respond to the Plaintiff's  
23 Complaint is January 21, 2025.

24 Plaintiff and the United States, through undersigned counsel, agree and stipulate  
25 that the United States' time to respond to the Plaintiff's Complaint shall be extended to  
26 February 4, 2025.

1 The United States requires additional time to obtain the underlying file from United  
2 States Citizenship and Immigration Services, to review the information received, and to
