 23 Defendant expects a substitution of counsel to be on file in the next 14 days.

24 This is the Parties second request for an extension. This stipulation is not for the purposes
 25 of delay. Given the short notice between Spencer Fane LLP entering the case (one day before the
 26 Opposition to the Motion to Remand was due), and defense counsel’s international vacation from
 27 March 1-12, Plaintiff graciously granted new defense counsel the professional courtesy of
