 16 1. Whereas an Order was entered September 15, 2010,  
 17 for Funding the Planning for Implementation of the Truckee  
 18 River Operating Agreement (TROA) for fiscal years October 1,  
 19 2011, through September 30, 2016.

 21 2. Whereas Additional Funding for "Studies and  
 22 Services" thereunder has been paid to the Federal Water  
 23 Master by the United States Bureau of Reclamation for their  
 24 commitment.

 26 3. Whereas the commencement of the Operation of the  
 27 Truckee River Agreement was on December 1, 2015, under the  
 28 management of the Federal Water Master.

1           4.   Whereas additional funds are necessary to fund the  
2 United States Bureau of Reclamation's commitment for the  
3 "Studies and Services" thereunder for the period October 1,  
4 2017 through March 31, 2019 as set forth in Exhibit "D" of  
5 the Order of September 15, 2010, and Exhibit "D" of this  
6 Order.


7           5.   Good cause appearing therefore, it is hereby  
8 ordered:

9           That the United States Bureau of Reclamation shall pay  
10 to the funds already held by the Federal Water Master, when  
11 such funds are available, the additional sum of THREE HUNDRED  
12 THOUSAND DOLLARS (\$300,000.00) to be used for the time period  
13 October 1, 2017 through March 31, 2019 for "Additional  
14 Studies and Services" under Truckee River Operating Agreement  
15 operation and management as set forth in Exhibit "D" of this  
16 Order.
