



1 4. Based upon the exchange of proposals, it is clear that the parties have significant  
2 differences on the content of a Scheduling Order and Discovery Plan.

3 5. In order to attempt to reach an agreement on the content of some or all of a  
4 proposed Scheduling Order and Discovery Plan, the parties require additional time to confer.

5 NOW, THEREFORE, pursuant to Rule 6(b) of the Federal Rules of Civil Procedure and  
6 LR IA6-1, the parties stipulate to extend to December 17, 2018 the time to submit the proposed  
7 Scheduling Order and Discovery Plan and Agenda for the December 19, 2018 Status  
8 Conference.
