16 ORDER APPROVING WATER MASTER'S BUDGET FOR 2017-2018;  
 17 CREATING AN ASSESSMENT TO REPLENISH THE FUND HERETOFORE  
 18 ESTABLISHED TO PAY THE EXPENSE OF CONDUCTING  
 19 THE WATER MASTER'S OFFICE, APPORTIONING THE COSTS  
 20 THEREOF, PROVIDING THE MANNER AND METHOD OF  
 21 COLLECTION THEREOF, AND DIRECTING THE DISTRIBUTION  
 22 OF THE WATERS OF THE CARSON RIVER WHEN NECESSARY

23 BE IT REMEMBERED that the petition of CHAD BLANCHARD,  
 24 Water Master appointed herein to administer the Final Decree  
 25 entered on December 18, 1980, asking that an assessment be  
 26 created to replenish the fund heretofore established to pay  
 27 the expenses of conducting the Office of the Water Master for  
 28 the period from October 1, 2017, to September 30, 2018, and  
 for such other action as might seem meet and proper in the

premises, having been filed with the Clerk of this Court on  
1 December 30, 2016, and proper notice having been given to all  
2 parties of the filing of said petition, and all parties having  
3 the opportunity to enter objections thereto, and no objections  
4 having been entered by any party to the said petition and  
5 proposed budget and good cause appearing,  
6

7 **NOW, THEREFORE, IT IS HEREBY ORDERED:**

8 1. That the budget submitted by the Water Master on  
9 December 22, 2017, as part of his petition, is hereby approved  
10 and the Water Master is hereby authorized and directed to pay  
11 to himself as Water Master the salary indicated in said budget,  
12 to employ assistants as may be necessary and to pay all  
13 necessary expenses incurred in administering the Final Decree  
14 issued herein, as provided for in said budget.  
15

16 2. That in order to provide a means for the payment of  
17 further expense of conducting the Water Master's Office,  
18 particularly for the period from October 1, 2017, to September  
19 30, 2018, there is hereby created an assessment in the sum of  
20 THREE HUNDRED TWENTY THOUSAND DOLLARS (\$320,000.00).  
21

22 3. That the water users within the Truckee-Carson  
23 Irrigation District, by and through the Truckee-Carson  
24 Irrigation District, pay to the Water Master one-fifth (1/5)  
25 of the said assessment, to wit, the sum of SIXTY-FOUR THOUSAND  
26 DOLLARS (\$64,00.00), said payment to be made on or before  
27  
28

April 30, 2018.

1           4.     That the balance of said assessment be assessed  
2 against all of the remaining water users on the Carson River  
3 subject to the jurisdiction of this Court, on a prorata bases  
4 of FOUR DOLLARS AND 10 CENTS (\$4.10) per acre, according to  
5 the irrigable acreage possessed by said water users, said  
6 payments to be made to the Water Master on or before April 30,  
7 2018, it being provided, however, that the minimum charge  
8 assessed against any water user shall not be less than FORTY-  
9 ONE DOLLARS AND NO CENTS (\$41.00).  
10

11           5.     That the Clerk of this Court give notice of the  
12 required payments to be made by each water user by mailing a  
13 copy of this order and the notice annexed hereto to each  
14 attorney appearing of record for the plaintiff and sundry  
15 defendants in this cause within five (5) days of the entry of  
16 this order; the Water Master is further directed to give such  
17 notice to the parties hereto and their successors and assigns  
18 by publishing a copy of the notice annexed hereto in the  
19 following newspapers: Nevada Appeal, P.O. Box 2288, Carson  
20 City, Nevada, 89701; Record-Courier, P.O. Box 2288, Carson  
21 City, Nevada 89702-2288; Lahontan Valley News, P.O. Box 1297,  
22 Fallon, Nevada 89407-1297 and Mason Valley News, P.O. Box 841,  
23 Yerington, Nevada 89447, once a week for two (2) consecutive  
24 weeks.

27

6. That the prorata amounts so assessed against the  
1 water users on the Carson River on the basis of the water  
2 righted acreage possessed by said water users shall become and  
3 be a lien against said water righted lands until paid, and  
4 that the Water Master be, and hereby is, directed to enforce  
5 the collection of said assessments, together with a reasonable  
6 late fee not less than TEN DOLLARS (\$10.00), in the manner  
7 provided by law, and is further ordered to cut off water  
8 deliveries from any water user who is in default in any said  
9 required payments.  
10

11  
12 7. That the Water Master, CHAD BLANCHARD, be and hereby  
13 is, directed to continue in effect the surety bond in the sum  
14 of FIFTY THOUSAND DOLLARS (\$50,000.00) heretofore provided  
15 pursuant to his order of appointment for the faithful  
16 performance of his duties as custodian of such funds and the  
17 property that may be in his care.  
18

19 8. That the Water Master's report and audit for the  
20 fiscal year ending September 30, 2018, shall be filed by  
21 January 15, 2019. The Water Master's report and audit for the  
22 fiscal year ending September 30, 2017 filed on the 22nd day of  
23 December 2017, is hereby approved.  
24

25 9. That the operation and administration of the Water  
26 Master's Office in administering the provisions of the Final  
27 Decree for the period from October 1, 2016, to September 30,  
28

2017 is hereby approved.

1           10. That the Water Master begin the distribution of the  
2 waters of the Carson River under said Final Decree on such  
3 date as the Water Master determines that the distribution of  
4 said water under his authority is necessary.  
5

6           11. That the Water Master is directed to create a funded  
7 account pursuant to existing Personnel and Benefits Policy to  
8 cover the cost of continuing health insurance on qualified  
9 personnel, upon their retirement, and that the cost shall be  
10 included in the Water Master's Budget each year until such  
11 time as the earned benefit is exhausted.  
12
