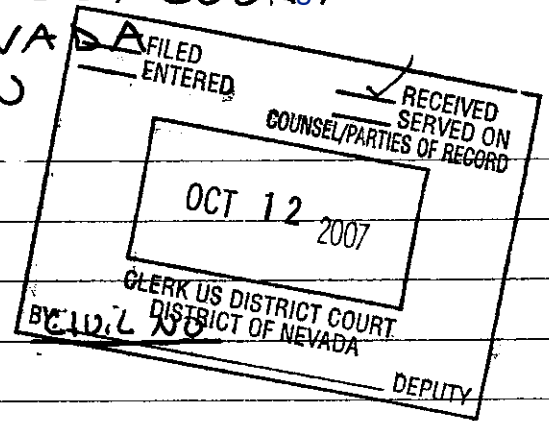

COMPLAINT
"SEXUAL HARASSMENT"
