
ORDER

23 It is hereby ordered that Defendants shall tender the settlement payment check to
 24 Plaintiffs by delivery to Cal J. Potter, III, Esq., who shall deposit the funds in his client trust
 25 account. The settlement funds shall not be removed from Mr. Potter's trust account until the
 26 state probate court with jurisdiction over the estate of decedent Patrick J. Cavanaugh, Sr.,
 27 shall issue an order approving the compromise and settlement, by the duly appointed
 28 administrator or personal representative of said estate, of the claim of said estate asserted in

1 this action, and further until said order of said probate court shall be presented to and
2 approved by counsel for Defendants. Upon approval of the compromise and settlement of
3 the claim of the estate by the probate court, the Plaintiffs may remove the settlement funds in
4 Mr. Potters' trust account except as otherwise limited by court order or applicable law.




