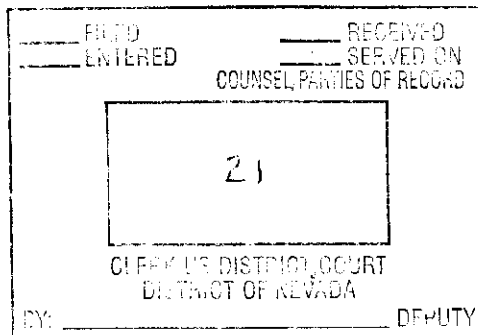

22 ATTORNEYS OF RECORD:


23 WHEREAS plaintiff has agreed to dismiss all Defendants, PECETTI RANCH


