15	Before this court is the Second Amended Report and Recommendation of Magistrate
16	Judge Valerie Cooke, ECF No. 642 <sup>1</sup> , which resolves several motions in the following manner:
17	(1) recommends denying plaintiff's motion for summary judgment, ECF No. 598; (2) denies
18	plaintiff's motion to exclude evidence or, alternatively, strike exhibits, ECF No. 617; (3) grants
19	plaintiff's motion to strike, ECF No. 628; and (4) recommends granting in part and denying in
20	part defendants' motion for summary judgment, ECF No. 608. Plaintiff and defendants both
21	objected to the Second Amended Report and Recommendation. ECF Nos. 643, 645.
22	This action was referred to Judge Cooke under 28 U.S.C. § 636(b)(1)(B) and Local Rule
23	IB 1-4 of the Rules of Practice of the United States District Court for the District of Nevada.
24	The court has conducted a de novo review in this case, has fully considered the pleadings
25	and memoranda of the parties-including the parties' objections to the Second Amended Report
26	and Recommendation—and other relevant matters of record under 28 U.S.C. § 636(b)(1)(B) and

1	Local Rule IB 3-2. The court determines that Judge Cooke's Second Amended Report and
2	Recommendation, ECF No. 642, shall be adopted and accepted.
3	IT IS THEREFORE ORDERED that plaintiff's objections (ECF No. 645) and
4	defendants' objections (ECF No. 643) to the Magistrate Judge's Second Amended Report and
5	Recommendation are <b>OVERRULED</b> .
6	IT IS FURTHER ORDERED that the Magistrate Judge's Second Amended Report and
7	Recommendation (ECF No. 642) entered on June 14, 2018, is ADOPTED AND ACCEPTED.
8	Plaintiff's motion for summary judgment (ECF No. 598) is <b>DENIED.</b> Plaintiff's motion to
9	exclude evidence or, alternatively, to strike exhibits (ECF No. 617) is <b>DENIED.</b> Plaintiff's
10	motion to strike (ECF No. 628) is GRANTED. Defendants' motion for summary judgment
11	(ECF No. 608) is GRANTED IN PART AND DENIED IN PART. Plaintiff's due process
12	claim against defendant Yaqub Mustafaa shall be the only claim to proceed. The remaining
13	claims and defendants shall be dismissed.
14	IT IS FURTHER ORDERED that the parties shall file their proposed joint pretrial order
15	pursuant to Local Rules 16-3 and 16-4 within forty-five (45) days of the entry of this order.

17	IT IS SO ORDERED.
