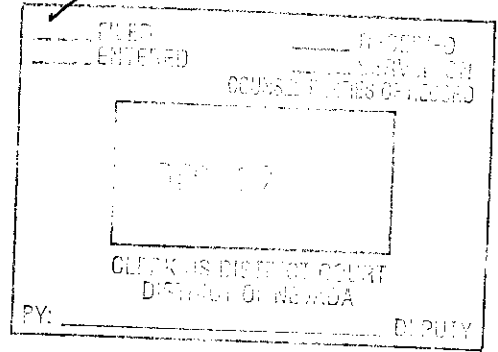

20 **(First Request)**


21 Defendants, by and through their attorneys, Catherine Cortez Masto, Attorney General
22 of the State of Nevada, and Janet E. Traut, Senior Deputy Attorney General, move for an
23 enlargement of time in which to complete and file their dispositive motion in this case. The
24 motion is due on December 15, 2010. Defendants request an additional three weeks in which
25 to complete the motion, which would make it due on January 5, 2011. Defendants have been
26 unable to complete the motion by today's deadline due to the press of business as well as the
27 impact of furlough days on both client and counsel, and the unavailability of some staff due to
28 annual leave which must be used or forfeited by the end of the calendar year. The three weeks'
time and carry-over into the new year should remedy all of these issues. Counsel was still
hopeful after the close of business today that the motion could be completed, and so did not
attempt to contact opposing counsel timely to obtain a stipulation for the requested

1 enlargement. Counsel certifies that this enlargement is requested in good faith and is not for
2 purposes of unnecessary delay.


