NOW, on motion of Lionel Sawyer & Collins, attorneys for Plaintiffs, it is hereby

ORDERED and ADJUDGED that Plaintiffs respectively do recover of Defendant Kenzie as follows:

Plaintiff Jeffrey L. Jarvis, the sum of \$247,444.59 (the amount claimed); plus pre-judgment interest pursuant to NRS 17.130(2) from the date of service of the summons and complaint through June 27, 2011 in the amount of \$1,103.29 plus additional interest through the date of judgment, to be calculated at the statutory rate of 5.25%; plus post-judgment interest, to be calculated pursuant to 28 U.S.C. § 1961;

1 **Plaintiff Brenda K. Holtzman**, the sum of \$50,000.00 (the amount claimed); plus pre-
2 judgment interest pursuant to NRS 17.130(2) from the date of service of the summons and complaint
3 through June 27, 2011 in the amount of \$222.80 plus additional interest through the date of
4 judgment, to be calculated at the statutory rate of 5.25%; plus post-judgment interest, to be
5 calculated pursuant to 28 U.S.C. § 1961;

6 **Plaintiff Katherine L. Jarvis**, the sum of \$48,053.55 (the amount claimed); plus pre-
7 judgment interest pursuant to NRS 17.130(2) from the date of service of the summons and complaint
8 through June 27, 2011 in the amount of \$214.24 plus additional interest through the date of
9 judgment, to be calculated at the statutory rate of 5.25%; plus post-judgment interest, to be
10 calculated pursuant to 28 U.S.C. § 1961; and

11 **Plaintiff Jarvis Mechanical Constructors, Inc.**, in the sum of \$275,000.00 (the amount
12 claimed); plus pre-judgment interest pursuant to NRS 17.130(2) from the date of service of the
13 summons and complaint through June 27, 2011 in the amount of \$1,226.05 plus additional interest
14 through the date of judgment, to be calculated at the statutory rate of 5.25%; plus post-judgment
15 interest, to be calculated pursuant to 28 U.S.C. § 1961; and that Plaintiffs have execution therefor.
