**ENTRY OF A QUALIFIED PROTECTIVE**

25 The undersigned stipulate and agree as follows:

26 1. This Confidentiality Agreement and Protective Order (the "Order") shall apply  
 27 to documents, materials, and information that a party to this litigation has produced or may  
 28 produce which that party in good faith believes contains confidential or proprietary business,  
 personnel, or financial information, or personal health information as contemplated under the  
 Health Insurance Portability and Accountability Act of 1996 ("HIPAA") (collectively,  
 "Information").

2. All Information produced in this litigation and designated as "Confidential" as  
 provided below shall be used solely for the purpose of this litigation, and will not be used or  
 disclosed outside the context of this litigation. Any person receiving such Information

1 designated as Confidential shall restrict its disclosure to persons authorized to receive the  
2 Information designated as "Confidential" pursuant to this Order. A Confidential designation is  
3 applicable to all copies and reproductions of any Information. Nothing herein shall be deemed  
4 to restrict the right of the producing party to use its own Information that it has designated as  
5 Confidential as it chooses. Nothing in this Order requires either party to produce Information  
6 the party believes is privileged or otherwise non-discoverable. By entering into this Order, the  
7 parties do not waive any right to object to any discovery request, to the admission of evidence  
8 on any ground, to seek further protective order, or to seek relief from the Court from any  
9 provision of this Order.

10 3. Designating Information as Confidential: All or any part of a document, item,  
11 testimony, or other Information disclosed, produced, or filed in this litigation may be  
12 designated as Confidential by marking the word "Confidential" on the face of the original of  
13 the document and each page so designated, or on the face of the photocopy of the document,  
14 and on the photocopies of each page so designated, except as to documents containing more  
15 than twenty-five (25) pages, in which case marking the top page as Confidential will suffice.  
16 Oral testimony may be designated as Confidential during the deposition or proceeding, with  
17 reasonable precision as to the affected testimony, or within seven (7) business days after  
18 receipt of the transcript of such deposition or proceeding by sending written notice designating,  
19 by page and line, the portions of the transcript of the deposition or other testimony to be treated  
20 as Confidential. All or any part of responses to interrogatories or to requests for admission or  
21 for production of documents may be designated as Confidential on the face of the response and  
22 each page so designated.

23 4. Challenging a Designation: Either party may challenge at any time the  
24 propriety of a designation of Information as Confidential. Before seeking relief from the  
25 Court, the parties shall attempt to resolve the dispute informally and in good faith. If the  
26 parties are unable to resolve such dispute, it shall be submitted to the Court. The Information  
27 shall be treated as Confidential pending resolution of the challenge.

1           5.     No Implied Acknowledgement of Confidentiality: Compliance with the terms  
2 of this Order, production or receipt of Information designated Confidential, and/or allowing  
3 Information to be designated Confidential shall not in any way operate as an admission that  
4 any particular Information is Confidential. Failure to challenge the designation of Information  
5 as Confidential does not preclude a subsequent challenge. The designation of Information as  
6 Confidential does not create a presumption in favor of or against that designation.

7           6.     Access to Information Designated Confidential: Access to Information  
8 designated Confidential is restricted to the following persons:

9                 (a)     Counsel of record for the respective parties, including office associates,  
10                        paralegals, stenographic and clerical employees;

11                (b)     The parties to this action and their representatives, including in-house  
12                        counsel;

13                (c)     Experts or consultants (including their employees, associates, and/or  
14                        support staff) who are employed, retained or otherwise consulted by counsel or a party  
15                        for the purpose of analyzing data, conducting studies, or providing opinions to assist in  
16                        any way in the litigation. Information designated Confidential that is accessed by  
17                        experts or consultants shall be limited to documents that the experts or consultants  
18                        reasonably need to review in their roles as experts or consultants;

19                (d)     Electronic imaging and/or computer litigation support personnel retained  
20                        by one or more of the parties in this litigation or by the parties' counsel;

21                (e)     The Court and its personnel, including clerks and stenographic reporters  
22                        who record depositions of other testimony in this litigation;

23                (f)     Outside photocopying services, graphic production services, or litigation  
24                        support services employed by the parties or their counsel to assist in this litigation, and  
25                        computer personnel performing duties in relation to a computerized litigation system;  
26                        and

27                (g)     Any other person to whom the producing party agrees in writing.  
28

1           The parties shall inform each person to whom they disclose or give access to the other  
2 party's Information designated Confidential of the terms of this Order, as well as the obligation  
3 to comply with its terms.

4           7.     Depositions: To the extent depositions occur in this litigation, persons may be  
5 deposed regarding Information of which they have knowledge which have been designated  
6 Confidential. Any court reporter who transcribes testimony in this action at a deposition shall  
7 agree, before transcribing any such testimony, that all testimony containing Confidential  
8 Information is and shall remain Confidential and shall not be disclosed except as provided in  
9 this Order and that copies of any transcript, reporter's notes or any other transcription records  
10 of any such testimony will be retained in absolute confidentiality and safekeeping by such  
11 shorthand reporter or delivered to attorneys of record.

12           8.     Previously Produced Information: This Order does not affect the right of the  
13 parties to designate as Confidential any Information which has been produced prior to the entry  
14 of this Order. Any disclosure of such Information prior to its designation as Confidential shall  
15 not be deemed a violation of this Order. This Order shall not prejudice the right of the parties  
16 to designate as Confidential the Information a party has inadvertently produced without the  
17 sought designation.

18           9.     Filing Documents Under Seal: If a party seeks to file Information designated  
19 Confidential with the Court, the party seeking to file such Information must first submit a  
20 Motion to Allow Filing Under Seal to the Court, unless the party to whom the confidential  
21 Information pertains agrees in writing that such Information need not be filed under seal. A  
22 Motion to Allow Filing Under Seal must include a specific description of the Information or  
23 categories of Information it seeks to file under seal, along with a clear statement of the facts  
24 justifying a seal, including the harm which would result if the Information was not filed under  
25 seal. Such statement must be made by declaration or affidavit. A party may request that such  
26 Motion be heard on an Order Shortening Time or emergency basis and the other party hereby  
27 consents to the Court shortening the time for such a motion. If a party seeks to file under seal  
28 Information designated Confidential as part of a dispositive motion, that party must

1 demonstrate compelling reasons to the Court for preserving the secrecy of that Information. If  
2 a party seeks to file under seal Information designated Confidential as part of a non-dispositive  
3 motion, that party must demonstrate good cause to the Court for preserving the secrecy of that  
4 Information. If the party seeking to file such confidential Information is not the party to whom  
5 the confidential Information pertains, the party to whom the confidential Information pertains  
6 may also seek to demonstrate good cause or compelling reasons to the Court for preserving the  
7 secrecy of that Information, independently of whatever showing is made by the party seeking  
8 to file such Information. Until the parties otherwise agree or the Court so determines, all  
9 Information designated Confidential shall continue to be treated as Confidential in accordance  
10 with this Order. In the event the Court refuses to allow the filing under seal of such  
11 Information designated as Confidential, a party shall still be permitted to file such Information,  
12 but it will continue to be treated as Confidential in all other respects. The Court may change  
13 the terms of this section of this Order on its own motion after notice to the parties and an  
14 opportunity to be heard. All filing deadlines will be tolled while a motion that is filed under  
15 this section is pending before the court.

16 10. Conclusion of Proceedings: Within forty-five (45) days following termination  
17 of this litigation by final judgment, settlement or otherwise (including any appeals):

18 (a) All Information subject to the provisions of this Order shall be destroyed  
19 or delivered to the producing party or the Third Party that produced the documents.

20 (b) To the extent any Information designated Confidential is destroyed, the  
21 destroying party shall so represent in writing to the producing party.

22 (c) As to Information filed under seal, the producing party shall be obligated  
23 to retrieve those documents from the Court and the other party will support any motion  
24 to this effect.

25 11. Jurisdiction and Enforcement: Any person to whom Information designated  
26 Confidential is disclosed shall be subject to the jurisdiction of the Court for purposes of  
27 determining, assuring, and adjudging such person's compliance with this Order. This  
28 jurisdiction shall survive the termination of this litigation. Any party or person subject to this

1 Order who violates its provisions shall be liable for damages for any injuries or loss suffered by  
2 the producing party as a result of such violation.


3 12. This Order and the agreement embodied herein shall survive the termination of  
4 this litigation and continue in full force and effect.


