O R D E R

1 Pursuant to the Second Amended Scheduling Order dated June 7, 2017, the parties
2 are to file a Supplemental Joint Claim Construction and Prehearing Statement by November
3 29, 2017. (ECF No. 97.)

4 Pursuant to that order and the Local Patent Rules, Plaintiff Server Technology, Inc.


