**ORDER RESCHEDULING STATUS
CONFERENCE**

(Second Request)

The parties stipulate and request that the Status Conference currently scheduled for January 18, 2019 be rescheduled to either March 1 or March 8, 2019 in Las Vegas or another date thereafter that is convenient for the Court.

The parties make this request for the following reasons:

1 1. Defendant Zappos.com, Inc. filed a Petition for Writ of Certiorari in the
2 Supreme Court (Case No. 18-225) on August 20, 2018;

3 2. This Court originally scheduled a Status Conference in this case on
4 November 14, 2018 at 9:00 a.m. in Las Vegas (ECF No. 311);

5 3. Because the parties did not expect to complete briefing on the Petition for
6 Writ of Certiorari in the Supreme Court until late November 2018, the parties jointly requested,
7 by stipulation, that the Court continue that Status Conference until January 18, 2019 (ECF No.
8 313);

9 4. The Court granted the parties' stipulation and continued the Status
10 Conference until January 18, 2019 (ECF No. 314);

11 5. The Supreme Court has not yet acted on the Petition for Writ of Certiorari;

12 6. The parties do not know whether the Supreme Court will grant or deny the
13 Petition for Writ of Certiorari before this Court's January 18, 2019 Status Conference; and

14 7. The parties will be in a better position to inform this Court as to the status
15 of this case after the Supreme Court has decided whether to grant or deny the Petition for Writ of
16 Certiorari.


