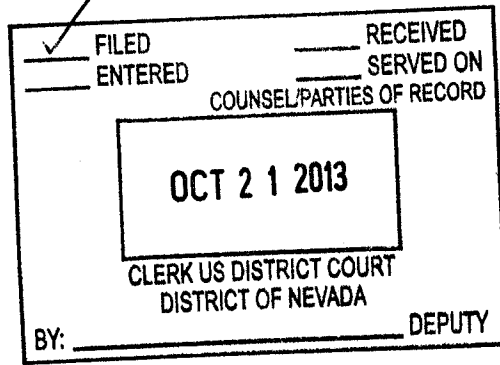

19 **DEFENDANT'S NOTICE OF RESUMPTION OF**
20 **APPROPRIATIONS AND NEW DEADLINE FOR RESPONSE**

22 Defendant Carolyn Colvin, Acting Commissioner of Social Security, hereby notifies the Court
23 and counsel that appropriations for the United States Department of Justice and Defendant have
24 resumed as of October 17, 2013. This notice is provided in compliance with the stay order previously
25 entered by the Court in this matter, which, by its terms, was effective during the period of lapse in
26 appropriations.

27 Defendant's response to motion for remand was originally due on October 15, 2013. Pursuant
28 to the application for stay during lapse in appropriations, the current deadline should be extended

1 commensurate with the duration of the lapse in appropriations, which was 16 days. Therefore, the new
2 deadline for Defendant's response to motion for remand should be October 31, 2013.
