1 Pursuant to Federal Rule of Civil Procedure 26(f) and Local Rule of Practice 26-1 and  
2 the Court's October 29, 2013 Minute Order (Doc. 59), Plaintiff Digcom, Inc. ("Plaintiff"), by  
3 its attorneys, and Defendant ZTE (USA) Inc. ("Defendant" or "ZTE USA"), by its attorneys,  
4 submit this case management report regarding scheduling and discovery issues and their  
5 proposed plans.

6  
7 **I. Nature of the Case and Description of the Principle Factual and Legal**  
8 **Disputes**

9 A. Plaintiff: Digcom, Inc. asserts patent infringement of four U.S. patents (either  
10 literally or under the doctrine of equivalents) against ZTE USA. The four patents-in-suit are:

- 11 • United States Patent No. 7,805,143, entitled "Mobile Video Internet, Cellular  
12 and Location Finder System" (the "143 patent")
- 13 • United States Patent No. 7,809,374, entitled "Video Mobile Communication  
14 System" (the "374 patent")
- 15 • United States Patent No. 7,899,491, entitled "Cross-correlated Quadrature  
16 Modulated Spread Spectrum, OFDM and Position Finder System" (the "491  
17 patent")
- 18 • United States Patent No. 7,983,678, entitled "3G and Wi-Fi Connected Mobile  
19 Systems" (the "678 patent")

20 The devices made, used or sold by ZTE USA which Digcom has accused of  
21 infringement are, generally speaking, mobile smart phones, including but not limited to the  
22 ZTE Fury (at least model N850), the ZTE Optik (at least model V55), and the ZTE Concord  
23 (at least model V768).

24 Digcom seeks damages adequate to compensate Plaintiff for infringement, which in no  
25 event can be less than a reasonable royalty.

26 B. Defendant: ZTE USA asserts it does not infringe any valid and enforceable  
27 claim of the four patents-in-suit, either literally or under the doctrine of equivalents, and  
28 asserts numerous invalidity and unenforceability defenses. Defendant contends that Plaintiff  
is not entitled to any award of damages and reserves its rights to seek an award of fees and

1 costs incurred by it in connection with this action. As Plaintiff has not yet provided  
2 infringement contentions, it is impossible for ZTE USA to know with specificity the exact  
3 defenses it will assert or which equitable principals are applicable to the claims of the  
4 Plaintiff. ZTE USA anticipates that it will assert one or more of the following defenses: (i)  
5 each asserted claim of the patents-in-suit is invalid and/or unenforceable for failure to comply  
6 with one or more of the conditions for patentability set forth in at least, *e.g.*, 35 U.S.C. §§ 101,  
7 102, 103 and 112; (ii) Plaintiff's claims for patent infringement are precluded to the extent  
8 that any allegedly infringing products or components thereof are supplied, directly or  
9 indirectly, to Defendant by any entity or entities having express or implied licenses to the  
10 patents-in-suit and/or under the doctrine of patent exhaustion; (iii) Plaintiff is barred under  
11 principles of equity (*e.g.*, laches, prosecution laches, waiver, estoppel, unclean hands); (iv)  
12 Plaintiff's claims for damages and/or costs are limited and/or barred under 35 U.S.C. §§ 286,  
13 287 and/or 288; (v) Plaintiff is not entitled to any equitable relief (*e.g.*, injunctive relief)  
14 because any alleged injury to Plaintiff is not immediate or irreparable, Plaintiff has an  
15 adequate remedy at law and/or public policy concerns weigh against any such relief; (vi)  
16 Plaintiff has failed to state a claim upon which relief can be granted; and/or (vii) by reason of  
17 the proceedings in the U.S. Patent and Trademark Office during the prosecution of the  
18 application which resulted in the issuance of the patents in suit, Plaintiff is estopped from  
19 claiming infringement by the Defendants of one or more claims of the patents in suit.

## 24 **II. Jurisdictional Bases for the Case**

25 The parties agree that this Court has subject matter jurisdiction over this case under 28  
26 U.S.C. §§ 1331 and 1338(a). However, ZTE USA contests that venue is proper in this  
27 District.

1                   **III.    Parties Named in Complaint and Status of Service**

2           Plaintiff:     Digcom, Inc.

3           Defendants:

- 4           •       ZTE USA, Inc. has been served, and filed its answer to Plaintiff's Complaint  
5                   for Patent Infringement on July 22, 2013, 2013 (Doc. 33).  
6  
7           •       ZTE Corporation and ZTE Solutions Inc. were named in the Complaint, they  
8                   have since been dismissed without prejudice. The parties request that the  
9                   Court amend the case caption to identify ZTE (USA) Inc. as the sole  
10                  defendant.

11                   **IV.    Prospect of Adding Additional Parties and Amending Pleadings**

12                   Plaintiff is not presently aware of any other parties that may be necessary for the full  
13                   adjudication of this matter.  
14

15                   Defendant believes that additional parties may be necessary depending on the nature  
16                   of Plaintiff's infringement allegations, as Defendant's accused products utilize components  
17                   that originate from third-party suppliers and about which ZTE USA has no technical  
18                   information necessary to defend this case.  
19

20                   **V.    List of Contemplated Motions**

21                   Plaintiff currently contemplates the possibility of at least one motion for summary  
22                   judgment concerning infringement by the Defendant of one or more of the patents-in-suit.  
23

24                   ZTE USA has no contacts with Nevada. Thus, as of the date of this report ZTE USA  
25                   plans to file a motion to transfer the action to the Southern District of California, where ZTE  
26                   USA has a technical facility and where the ZTE USA supplier (Qualcomm) is located, who  
27                   ZTE USA expects will have the bulk of technical information relating to the accused  
28

1 components of the ZTE USA products at issue. As appropriate, Defendant contemplates the  
2 possibility of one of more summary judgment motions, *Daubert* motions and *in limine*  
3 motions after the close of discovery. ZTE USA hopes to avoid, but reserves the right to seek  
4 as needed, motions to compel to resolve discovery disputes.

5 **VI. Pending Motions**

6 No motions are pending as of the date of this report.

7 **VII. Status of Related Cases**

8 A. Earlier-filed case No. 3:13-cv-00176; titled Digcom, Inc., a Nevada  
9 Corporation vs. Casio Computer Co., Ltd., Casio America, Inc., and NEC Casio Mobile  
10 Communications, Ltd. (collectively, “Casio Defendants”) has been settled. Digcom  
11 announced settlement, and dismissed all claims pending against the Casio Defendants, in its  
12 Notice of Plaintiff’s Voluntary Dismissal dated November 5, 2013 (See *Digcom, Inc. vs.*  
13 *Casio Computer Co., Ltd., et al.*, Case No. 3:13-cv-00176 (Doc. 28)).

14 B. Earlier-filed case No. 3:13-cv-00177, titled Digcom, Inc., a Nevada  
15 Corporation, vs. Pantech Co. Ltd., et al., remains pending. The Case Management  
16 Conference in that matter is set immediately prior to the Case Management Conference in this  
17 matter before Magistrate Judge Cooke (See *Digcom, Inc. vs. Pantech Co. Ltd., et al.*, Case No.  
18 3:13-cv-00177 (Doc. 56)).

19 **VIII. Initial Disclosures Under Federal Rule of Civil Procedure 26(a)**

20 The parties have agreed that initial disclosures under Rule 26(a) shall be exchanged no  
21 later than December 21, 2013.

22 **IX. Local Rule 26-1(e)(1) – Discovery Cut-Off Date**

1 The parties propose that discovery be phased in this case and all discovery unrelated to  
 2 claim construction issues be deferred until the Court has issued a claim construction order.  
 3 The parties propose that the discovery cut-off date for claim construction issues be August 15,  
 4 2014 as to all asserted patents in this matter. The parties propose that the parties meet and  
 5 confer and file a proposed amended scheduling order regarding remaining discovery 30 days  
 6 after the entry of a claim construction order.  
 7

8 **X. The Parties' Proposed Schedules**

9 The parties have competing proposals regarding the schedule for exchange of  
 10 contentions, claim construction related events, expert disclosures, discovery and trial:

20 **XI. Pretrial Order**

21 To give the Court adequate time to decide the dispositive motions, the parties believe  
22 that the date for the pre-trial conference should not be set at this time.

23 **XII. Electronically Stored Information**

24 The parties have discussed the issue of electronic discovery, and Plaintiff does not  
25 believe electronic discovery will present any exceptional difficulties.  
26

27 Defendant believes that discovery of electronically stored information should be  
28 limited in this case and that no discovery of e-mails will be necessary. If discovery of



1 electronically stored information is necessary, Defendant proposed that the parties meet and  
2 confer to reach agreement on the format of production.

3 The parties agree to be bound by the provisions of the Federal Circuit's [Model] Order  
4 regarding E-Discovery in Patent Cases (attached as Exhibit A).

5 **XIII. Protective Order**

6 The parties believe that a stipulated protective order should be entered to govern the  
7 exchange of confidential information in this case. The parties agree to meet and confer in  
8 good faith to submit to the Court a joint protective order.

9 **XIV. Issues Related to Claims of Privilege or Work Product**

10 The parties agree that all communications or documents generated after the filing of  
11 the original complaint in this case do not need to be identified on a privilege log. As to any  
12 other issues, the parties agree to comply with Fed. R. Civ. P. 26(b)(5)(A).

13 **XV. Supplemental Discussion of Necessary Discovery**

14 A. The extent, nature and location of discovery anticipated by the parties  
15 Plaintiff anticipates taking Rule 30(b)(6) deposition testimony from Defendant  
16 covering topics concerning the functioning, structure, components and features of the accused  
17 devices, as well as the number of accused devices sold in the relevant period, their cost to  
18 Defendant, and the revenues realized by Defendant through the sale of the accused devices.

19 Plaintiff believes that documents that may be requested of Plaintiff by Defendant, if in  
20 Plaintiff's possession, custody or control, are likely located at Plaintiff's office in Incline  
21 Village, Nevada, or Plaintiff's counsel's offices.

22 Defendant anticipates that access to the technical information necessary to determine  
23 the infringement and validity issues may be difficult in view of the third parties who may be  
24

1 in possession of such information and documents rather than the parties in suit. Defendant  
2 anticipates that numerous witnesses will be deposed and document discovery may well be  
3 voluminous in this case.

4 B. Suggested revisions, if any, to the discovery limitations imposed by the  
5 Federal Rules of Civil Procedure and LR 26(1)(e)

6 None.

7 C. The number of hours permitted for each deposition, unless extended by the  
8 parties.

9 Pursuant to the Federal Rules of Civil Procedure, unless otherwise agreed to by the  
10 parties.

11 **XVI. Jury Trial Requested**

12 Both parties have requested a Jury Trial.

13 **XVII. Estimated Length of Trial**

14 The parties estimate that it will take 7-10 days to try this case.

15 **XVIII. Prospects for Settlement**

16 The parties have not yet engaged in substantive settlement discussions.

17 **XIX. Additional Matters**

18 A. E-Mail Service

19 Defendant proposes that, to the extent possible in light of the volume of the  
20 submissions, all court filings, to the extent not served through ECF (e.g., filings under seal),  
21 will be served via e-mail on all counsel who have entered an appearance on behalf of the party  
22 to be served, and such service shall constitute proper service under Fed. R. Civ. P. 5(b)(2)(E).  
23

24 Defendant further proposes that each party may serve discovery, in lieu of other service  
25 methods, by e-mail under Fed. R. Civ. P. 5(b)(2)(E) on all counsel who have entered an  
26  
27  
28

1 appearance on behalf of the party to be served. If transmission of voluminous materials as an  
2 e-mail attachment is impractical, those materials shall be sent via an FTP service or by  
3 overnight delivery. If service is by overnight delivery, the serving party must use a service  
4 having the ability to “track” deliveries and verify receipt.

5 B. Markman Tutorial

6 The parties believe that a short technology tutorial from each of the parties would be  
7 appropriate in this case. The parties will await the Court’s guidance as to whether and when  
8 tutorials should be submitted to the Court.
