ORDER EXTINGUISHING

22 The Defendant, Wells Fargo Bank, N.A., filed a Motion to Dismiss with Prejudice the
 23 Plaintiff's Complaint and Motion to Expunge Lis Pendens on June 28, 2013 as Docket Numbers
 24 2 and 3. The Plaintiff filed an Opposition to the Motion to Dismiss and Motion to Expunge Lis
 25 Pendens on July 15, 2013 as Docket Numbers 12 and 13. The Defendant, Wells Fargo Bank,
 26 N.A., filed a Reply in Support of the Motion to Dismiss and Motion to Expunge Lis Pendens on
 27 July 26, 2013 and July 31, 2013 as Docket Numbers 14 and 15. On October 9, 2013, the Court
 28 having considered all arguments presented, the pleadings on file herein, and the Court
 determining that good cause appearing, entered an Order granting the Motion to Dismiss and

1 Motion to Expunge Lis Pendens as Docket Number 18. Pursuant to the Court's Order entered on
2 October 9, 2013, the Court hereby rules as follows:

3 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that any Pendency of Action
4 or Lis Pendens recorded by the Plaintiff in the Official Records of Washoe County, Nevada on May
5 31, 2013 as Document Number 4243172, relating to this action and the real property that is subject
6 of this action located at 6369 Meadow Crest CL, Reno, Nevada, 89509, APN: 041-200-08 legally
