18 Pursuant to Local Rule IA 6-1 and LR 7-1 this *Stipulation and Order to Extend*

- 23 1. Plaintiff filed a Motion to File Under Seal Motion to Enforce Settlement [ECF

- 25 2. Wells Fargo sought extensions of time to file their Response due to a
 26 variety of circumstances, which were laid out in their Third Request for Extension of
 27 Time.
- 28 3. Plaintiff filed a Request for an extension of time to file the Reply because
 his client had been unable to review the Reply.


