

Freeman, Jr., hereby submit this status report regarding the settlement reached with Plaintiff Neill Samuell before Judge Valerie Cooke on August 23, 2016.

Defendants mailed a draft of the settlement agreement and stipulation to dismiss to Mr. Samuell on September 14. Defendants received Mr. Samuell's signed copies of the settlement agreement and the stipulation on Thursday, September 22. Defendants are preparing the settlement check and will forward it to the Nevada Department of Corrections as soon as possible, and file the stipulation to dismiss the same day.
