 19 Defendants Officer Dominick Cipriano, Officer Brian Fortner and Officer Joshua Taylor of
 20 the Las Vegas Metropolitan Police Department, by and through their attorney of record, Robert W.
 21 Freeman, Jr., hereby submit this status report regarding the settlement reached with Plaintiff Neill
 22 Samuell before Judge Valerie Cooke on August 23, 2016.

23 Defendants mailed a draft of the settlement agreement and stipulation to dismiss to Mr.
 24 Samuell on September 14. Defendants received Mr. Samuell's signed copies of the settlement
 25 agreement and the stipulation on Thursday, September 22. Defendants are preparing the settlement
 26 check and will forward it to the Nevada Department of Corrections as soon as possible, and file
 27 the stipulation to dismiss the same day. The Court ordered that a stipulation to dismiss in this
 28 matter be filed by September 23, 2016. Defendants request an additional 14 days to file the

1 stipulation to dismiss, so that it can be filed contemporaneously with the Court receiving the
2 settlement check.
