JOINT STATUS REPORT
IN COMPLIANCE WITH OCTOBER
1, 2014 ORDER (DOC. #23)

18 On September 12, 2014, the parties in this action attended a settlement conference with
19 The Honorable Magistrate Judge Valerie P. Cooke, during which the parties were unable to
20 reach a settlement of this action. (Doc. #21). Following the settlement conference, this Court
21 entered a Minute Order (Doc. #21), in which the Court stated as follows: “[t]he Court directs
22 counsel to file a status report regarding continued settlement negotiations by no later than the
23 close of business on Friday, September 26, 2014.” *Id.*

24 On September 25, 2014, the parties submitted a “Joint Status Report in Compliance with
25 September 12, 2014 Minute Order (Doc. #21),” in which the parties advised the Court that they
26 were continuing to negotiate settlement terms and requested that they be allowed to submit a
27 follow-up status report no later than October 10, 2014, advising the Court the status of
28 settlement discussions. (Doc. #22). On October 1, 2013, the Court issued an Order directing

1 the parties to submit another joint status report in the event settlement had not been reached.
2 (Doc. #23).

3 The parties are still in the process of negotiating a settlement and have exchanged drafts
4 of a written settlement agreement. The parties therefore respectfully request that they be
5 allowed to submit a follow-up status report no later than October 24, 2014, advising the Court
6 of the status of settlement discussions. In the event the parties execute a settlement agreement,
7 they will advise this Court, and also provide a timeline for submitting a dismissal with prejudice
8 pursuant to Fed. R. Civ. P. 41.

9 The parties agree that nothing in this Joint Status Report shall be construed as a waiver
10 of any rights or remedies belonging to any of the parties hereto.


