17 THE UNITED STATES ATTORNEY for the District of Nevada hereby moves, pursuant  
18 to LR-IA-10-3, for the admission of Dominika Tarczynska to the Bar of this Court for the  
19 purpose of representing the United States of America, its political subdivisions, officers, and  
20 employees, during the period of her employment by the United States as an attorney. It is  
21 anticipated that Ms. Tarczynska will enter an appearance in this action on behalf of the federal  
defendants.

22 Dominika Tarczynska has been a licensed attorney since 2006. Ms. Tarczynska is a  
23 member in good standing of the State Bar of New York (Bar # 4431573). Since 2011, Ms.  
24 Tarczynska has been an attorney employed by the United States Department of Justice,  
25 Environment and Natural Resources Division, Natural Resources Section, and her office is  
26 located in Washington, D.C. Ms. Tarczynska has never been subject to any disciplinary action  
27 by any bar.

28 LR-IA-10-3 provides that “ [u]nless otherwise ordered by the Court, any nonresident

1 attorney who is a member in good standing of the highest court of any state, commonwealth,  
2 territory or the District of Columbia, who is employed by the United States as an attorney and,  
3 while being so employed, has occasion to appear in this Court on behalf of the United States,  
4 shall, upon motion of the United States Attorney or the Federal Public Defender for this District  
5 or one of the assistants, be permitted to practice before this Court during the period of such  
6 employment.”

7 It is respectfully requested that an Order be issued permitting Dominika Tarczynska to  
8 practice before this Court during the period of her employment by the United States as an  
9 attorney. It is anticipated that Ms. Tarczynska will enter an appearance in this action on behalf  
10 of the federal defendants.
