13 **I. DISCUSSION**

14 Plaintiff, who is a prisoner in the custody of the Nevada Department of Corrections  
15 (“NDOC”), has submitted a motion to file a longer than normal civil rights complaint pursuant  
16 to 42 U.S.C. § 1983. (ECF No. 1-1). Plaintiff has not filed a complaint or an application to  
17 proceed *in forma pauperis* and has not paid the full filing fee for this matter.

18 Pursuant to Federal Rule of Civil Procedure 3, “[a] civil action is commenced by filing  
19 a complaint with the court.” Fed. R. Civ. P. 3. As such, the Court grants Plaintiff thirty (30)  
20 days from the date of this order to submit a complaint to this Court. The Court grants Plaintiff’s  
21 motion to file a longer than normal complaint (ECF No. 1-1).

22 Pursuant to 28 U.S.C. § 1915(a)(2) and Local Rule LSR 1-2, Plaintiff must complete an  
23 application to proceed *in forma pauperis* and attach both an inmate account statement for the  
24 past six months and a properly executed financial certificate. Plaintiff will be granted an  
25 opportunity to file an application to proceed *in forma pauperis*, or in the alternative, pay the full  
26 filing fee for this action. If Plaintiff chooses to file an application to proceed *in forma pauperis*  
27 he must file a fully complete application to proceed *in forma pauperis*.

1 **II. CONCLUSION**

2 For the foregoing reasons, IT IS ORDERED that the Clerk of the Court SHALL SEND  
3 Plaintiff the approved form application to proceed *in forma pauperis* by a prisoner, as well as  
4 the document entitled information and instructions for filing an *in forma pauperis* application.

5 IT IS FURTHER ORDERED that within **thirty (30) days** from the date of this order,  
6 Plaintiff shall either: (1) file a fully complete application to proceed *in forma pauperis*, on the  
7 correct form with complete financial attachments in compliance with 28 U.S.C. § 1915(a); or  
8 (2) pay the full \$400 fee for filing a civil action (which includes the \$350 filing fee and the \$50  
9 administrative fee).


10 IT IS FURTHER ORDERED that the motion to file a longer than normal complaint (ECF  
11 No. 1-1) is granted.

12 IT IS FURTHER ORDERED that Plaintiff shall submit a complaint to this Court within  
13 **thirty (30) days** of the date of this order.

14 IT IS FURTHER ORDERED that the Clerk of the Court shall send to Plaintiff the  
15 approved form for filing a 42 U.S.C. § 1983 complaint and instructions for the same.

16 IT IS FURTHER ORDERED that if Plaintiff does not timely comply with this order,  
17 dismissal of this action may result.
