**STIPULATION AND ORDER TO EXTEND THE BRIEFING
DEADLINES ON DEFENDANT’S MOTION TO DISMISS
(FIRST REQUEST)**

1 Defendant Navy Federal Credit Union (“Navy Federal”) and Plaintiff Gerardo Docena, by
2 and through their respective counsel of record, hereby stipulate and agree as follow:

3 1. Navy Federal filed a Motion to Dismiss (Dkt. No. 12) on June 30, 2015. Mr.
4 Docena’s response is currently due July 17, 2015.

5 2. Mr. Docena has requested additional time to file his opposition to the Motion to
6 Dismiss. In response to the request, Navy Federal requested additional time to file its reply brief in
7 support of the Motion to Dismiss.

8 3. Therefore, the parties stipulate and agree that Mr. Docena shall have up to and
9 including Friday, July 24, 2015, to file his opposition to the Motion to Dismiss. The parties further
10 stipulate and agree that Navy Federal shall have up to and including Tuesday, August 18, 2015,
11 within which to file its reply in support of the Motion to Dismiss.

12 4. The parties each requested extensions of time due to counsels’ obligations and
13 deadlines in other cases and planned vacations during the month of August. The extensions are not
14 being sought for the purpose of delay.

15 5. This is the first stipulation requesting an extension of time regarding the briefing on
16 Navy Federal’s Motion to Dismiss.
