21 Pursuant to LR IA 10-5, Brian A. Gonsalves, Esq., attorney for Plaintiffs TAMMY  
 22 SMITH, P.M., a minor by and through her Guardian ad Litem, and J.E., a minor by and through

6 **1. Standard of Law.**

7 LR IA 10-5 provides:

9 with the Court under seal shall be accompanied by a motion for leave to file  
10 those documents under seal, and shall be filed in accordance with the Court's  
11 electronic filing procedures."


11 **2. Legal Argument.**

12 During the April 20, 2016, hearing on the *Notice of Disassociation*, the Court directed  
13 Mr. Gonsalves to file his motion seeking the revocation of attorney Bradley Fell's pro hac vice  
14 admission no later than Friday, April 22, 2016. The *Ex Parte Motion for Order Revoking*  
15 *Approval of Pro Hac Vice Petition* contains information and communications between Plaintiffs'  
16 attorneys. In light of the pending settlement and ongoing state of this litigation and so as to
