3 hereby stipulate and agree that Kern shall have up to and including November 19, 2018, to file its
4 opposition to BANA's emergency motion to compel the deposition testimony of Gayle A. Kern,
5 Ltd., which is currently due on October 19, 2018, pursuant to ECF No. 94. The parties also agree
6 that BANA shall have up to and including November 30, 2018, to file its reply in support of its
7 emergency motion to compel the deposition testimony of Gayle A. Kern, Ltd.

9 The parties request this extension to allow for additional time to discuss a possible resolution
10 of the issues raised in the motion without the need for further court intervention; additionally, Kern's
