16 THE UNITED STATES ATTORNEY for the District of Nevada hereby moves, pursuant
17 to LR-IA-10-3, for the admission of Geoffrey C. Cook to the Bar of this Court for the purpose of
18 representing the United States of America, its political subdivisions, officers, and employees,
19 during the period of his employment by the United States as an attorney. It is anticipated that
20 Mr. Cook will enter an appearance in this action on behalf of the defendant United States.

21 Mr. Cook has been a licensed attorney since 1988. Mr. Cook is a member in good
22 standing of the District of Columbia Bar (Bar # 460301). Since 2007, Mr. Cook has been an
23 attorney employed by the United States Department of Justice, Civil Division, Environmental
24 Torts Branch, and his office is located in Washington, D.C.

25 LR-IA-10-3 provides that, “ [u]nless otherwise ordered by the Court, any nonresident
26 attorney who is a member in good standing of the highest court of any state, commonwealth,
27 territory or the District of Columbia, who is employed by the United States as an attorney and,
28 while being so employed, has occasion to appear in this Court on behalf of the United States,

1 shall, upon motion of the United States Attorney or the Federal Public Defender for this District
2 or one of the assistants, be permitted to practice before this Court during the period of such
3 employment.”

4 It is respectfully requested that an Order be issued permitting Geoffrey C. Cook to
5 practice before this Court during the period of his employment by the United States as an
6 attorney. It is anticipated that Mr. Cook will enter an appearance in this action on behalf of the
7 defendant United States.
