22 STIPULATION TO MEDIATE23 This stipulation is entered into on the date of the final signature, below, and concerns
24 the action filed in Federal District Court entitled, Cagle vs. Abadir, Case No. 3:16-cv-00229-
25 LRH-VPC. The parties, by and through counsel, agree to participate in good faith in a
26 mediation of the claims raised in plaintiffs' complaint upon the following terms:

- 27 1. Defendants will file their answer to the complaint on or before

- 28 June 17, 2016. Thereafter, the litigation will be stayed until July
-
- 31, 2016, in order to facilitate the mediation.

2. The parties agree to use the services of mediator John Aberasturi.
-
- The date, time and location of the mediation will be mutually
-
- agreed to in conjunction with the availability of the mediator.

3. Defendants will contact Mr. Aberasturi and obtain available
-
- dates, and coordinate scheduling.

- 1 4. Immediately upon execution of this stipulation, defendants will
2 provide plaintiff's counsel a complete copy of the Nevada Capital
3 Insurance Company policy issued to defendants. Defendants
4 make no representations on whether plaintiffs' claims are covered
5 by this policy, and affirmatively disclose to plaintiffs that NCIC
6 is defending this action under a reservation of rights.
- 7 5. The parties agree to exchange mediation statements so that each
8 side may understand the evidence in support of the other's claims
9 or defenses.
- 10 6. Plaintiffs will provide to defendants a demand at least two weeks
11 before the mediation, and defendants will respond to plaintiffs'
12 demand at least one week before the mediation.
