**ORDER TO PRODUCE  
 INMATE ROY GRIFFITH (#27757) FOR

16 Before the Court is Defendant’s Motion to Produce Inmate Roy Griffith (#27757) for

 25 Griffith (#27757) at the Bruce R. Thompson Courthouse, 400 South Virginia Street, Reno, Nevada  
 26 89501 from 8:30 a.m. until 5:00 p.m., or such other times ordered by the Court, for the evidentiary  
 27 hearing on May 7, 2018; and

2 Griffith to his prior location upon the conclusion of the hearing.
