25	"Defendants") have failed to appear, plead, or otherwise defend as required by the Federal Rules

3	IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Defendants have made

8	IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the statements addressed

14	PERMANENT INJUNCTION
15 16	IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:
17	A. Defendants and their agents and assigns are prohibited from any further acts of
18	defamation or publication of false and/or misleading statements, comments, or information
19	regarding RSU or its products on YouTube, Dailymotion, or any other website or publication;
20	B. The Parties are mandated to take all reasonable actions they can under the law to
21	remove the defamatory, disparaging, libelous, and false statements about RSU that Defendants
22	made in the videos published on YouTube and Dailymotion, including requesting that YouTube
23 24	and Dailymotion remove the videos Defendants published at the following URLs:

1	C. The Parties are mandated to request that Internet search engines such as Google,
2	Yahoo! and Bing remove from their search indices the URLs specified above; and
3	D. As it is possible that the above-referenced URLs and the videos contained therein
4	will appear on additional web pages or search engines in the future, including, but not limited to,
5	index, directory, and search results pages, The Parties are mandated to take all reasonable actions
6	available under the law to attempt to remove all such web pages from the Internet, including
7	requesting removal of all such web pages from the search engines of Google, Yahoo!, and Bing.
8	E. This case will be administratively closed. However, the Plaintiff may file an
9	application to have this case re-opened in the event that the videos identified above appear on
10	additional web pages or search engines in the future, and are not promptly removed by the
11	defendants.
12	IT IS SO ORDERED.
