**ORDER FOR LIMITED  
APPOINTMENT OF COUNSEL**

11 This case was referred to the *Pro Bono* Program (“Program”) adopted in General Order 2016-02  
12 for appointment of *pro bono* counsel. The Court has been informed that *pro bono* counsel has been  
13 identified. Victor Drakulich, Esq., is hereby appointed as counsel for plaintiff Ronald R. Santos. The  
14 scope of the appointment is for the **limited purpose** of participating in a settlement conference.

20 expenses or compensation for services in any manner authorized under the program.


21 IT IS FURTHER ORDERED that the Clerk of Court shall assign a PROBONO case flag and add  
22 Victor Drakulich, Esq. to the docket as counsel of record for plaintiff.

23 IT IS FURTHER ORDERED that Victor Drakulich, Esq. shall not be charged fees for use of the  
24 Court’s filing system in this matter for the duration of the appointment.

4 IT IS FURTHER ORDERED that within fourteen (14) days after completion legal services, Victor  
5 Drakulich, Esq. shall submit a Notice of Completion Form to the *Pro Bono Liaison*.
