17 THE UNITED STATES ATTORNEY for the District of Nevada hereby moves, pursuant
18 to LR-IA-11-3, for the admission of Michael Ceja Martinez to the Bar of this Court for the

28 member in good standing of the highest court of any state, commonwealth, territory or the

1 District of Columbia, who is employed by the United States as an attorney and has occasion to
2 appear in this court on behalf of the United States, is entitled to be permitted to practice before
3 this court during the period of employment upon motion by the employing federal entity, the
4 United States Attorney, the United States Trustees' Office, or the Federal Public Defender for
5 this District or one of the assistants.”

6 It is respectfully requested that an Order be issued permitting Michael Ceja Martinez to
7 practice before this Court during the period of his employment by the United States as an
8 attorney. It is anticipated that Mr. Martinez will enter an appearance in this action on behalf of
9 the respondent United States Environmental Protection Agency.
