3 advance of the case management conference currently set for August 14, 2017, at 9:00 a.m.

4 There are several pending motions currently before the Court. Defendant filed a Motion for
5 Judgment on the Pleadings (ECF No. 48), Motion to Stay Discovery (ECF No. 50) and Motion for
6 Protective Order on Subpoenas (ECF No. 51). Plaintiffs have responded to each of these motions
7 (ECF No. 60, 61, 67), and Defendants have replied. (ECF No. 68, 69, 70). Plaintiffs further moved
8 for leave to file a sur-reply with respect to the Motion for Judgment on the Pleadings, ECF No. 71,
9 and Defendants filed a response. ECF No. 73. Plaintiffs will be filing a reply and awaiting a
10 decision from the Court on permission to file a sur-reply.

11 The parties have been conferring regarding settlement and will be conducting focused
12 settlement discussions next week. Given the foregoing, and in an effort to minimize additional
13 expense in advance of the parties' settlement discussions, the parties hereby jointly request to
14 vacate the August 14, 2017, Case Management Conference.


