JOINT STATUS REPORT

1 Plaintiffs Fan Fi International, Inc. and ETL, LLC ("Plaintiffs") and Defendant Interlink
2 Products International, Inc. ("Defendant"), hereby submit this Joint Status Report pursuant to this
3 Court's minute order (ECF No. 85).

4 Over the past several weeks, the Parties have exchanged multiple drafts of a settlement
5 agreement that is intended to resolve this case as well as the case brought by Defendant against
6 Plaintiffs in the United States District Court for the District of New Jersey. While a few settlement
7 issues remain unresolved, the Parties have worked diligently to bridge the differences between
8 them to achieve a final written settlement agreement but will not be able to have a final agreement
9 executed by December 8, 2017.

10 The parties contemplate finalizing the settlement within the next 30 days and request the
11 Court allow the parties this additional time to complete the settlement. The parties propose that
12 they file before close of business on Monday, January 8, 2018, a stipulation for dismissal or a joint
13 case management report addressing how best to proceed with this case.


