20 Jeanette E. McPherson, Esq., as counsel for Shelley D. Krohn, Chapter 7 Trustee of the
 21 Alessi & Koenig Bankruptcy Estate, brings this Motion To Remove Attorney From Electronic
 22 Service List And Mailing Service List (“Motion”).

23 On December 13, 2016, Alessi & Koenig, LLC (the “Debtor”) filed a voluntary petition for
 24 relief under Chapter 7 of the Bankruptcy Code in the United States Bankruptcy Court for the
 25 District of Nevada (“Bankruptcy Court”), Case No. BK-S-16-16593-ABL (the “Bankruptcy
 26 Case”). Pursuant to 11 U.S.C. § 362(a), the filing of a bankruptcy petition operates as a stay of
 27 “the commencement or continuation . . . of a judicial, administrative, or other action or proceeding
 28 against the debtor. . . .”

In the Debtor’s Bankruptcy Case, the automatic stay under 11 U.S.C. § 362 was terminated
 for all purposes, with the exception that collection of a judgment obtained against the Debtor may
 only be pursued against the Debtor in the United States Bankruptcy Court for the District of
 Nevada, BK-S-16-16593-ABL. See attached **Exhibit 1**.

In general, the automatic stay was terminated because the pending litigation and

1 participation in the litigation would not provide benefit to the Debtor’s bankruptcy estate. As a
2 result, the Trustee and her counsel will not be participating in any matter in which the Debtor is a
3 party, and the parties may proceed against the Debtor if in accordance with the order attached
4 hereto as **Exhibit 1**.

5 In addition, because the Trustee and her counsel will not be participating in any matter
6 which the Debtor is a party, the Trustee and her counsel request that they be removed from both
7 the Court’s CM/ECF and mailing service list with respect to the above referenced action.
