9 The Friday service That we go to is not
10 Jumma. All we do per. His order is allow to only
11 watch DVD vidoes. This is not How Friday service
12 congregational Prayer consist of. I am THE Imam
13 Here for THE muslim community. Friday Prayer consist
14 of PRAYER when we first enter THE chapel, a sermon (KUTBAH)
15 by a Imam or someone of Islamic knowledge. 2.
16 The second part of THE (KUTBAH) sermon consist of
17 Islamic Community affairs. 3rd To Have congregational
18 PRAYER. Chaplain Synder, denies us THE fundamental
19 basic LAW, Thus, Govern by THE U.S. Constitution, This
20 our right to practise our religion, not THE way He
21 feel we should practise. It is not His LAW, its
22 Islam, THE sunni of PROPHET muHAMMED (PBUH)

23 IT is a parent THAT He HAS ill feelings and discriminating
24 action against muslims. But He can not dictate legislative
25 LAWS, U.S. Constitution THAT allows up the right
