1 WHEREAS, Plaintiff Charles Garner (“Plaintiff”) filed a Complaint (the “Complaint”) in this
2 action on January 10, 2017 against Accurate Background, Inc. and Starbucks Corporation
3 (“Starbucks”), alleging violation of the Fair Credit Reporting Act.

4 WHEREAS, Plaintiff and Starbucks have entered into a voluntary and confidential settlement
5 agreement on May 1, 2017 (the “Settlement Agreement”), dismissing all claims against Starbucks
6 with prejudice with each party bearing its own fees and costs.

7 WHEREAS, on April 19, 2017, this Court ordered the dismissal without prejudice of
8 Plaintiff’s claims against Accurate Background, Inc. (ECF No. 28).

9 **NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED that**

10 Plaintiff’s Complaint against Starbucks is dismissed with prejudice. All remaining parties
11 have signed this stipulation. No trial date has been set in this case.
