3 TIME TO RESPOND TO DEFENDANTS
4 DANIEL HALL AND DIANA HALL'S
5 MOTION TO DISMISS OR FOR
6 SUMMARY JUDGMENT**

7 Plaintiff, Bank of America, N.A. successor by merger to BAC Home Loans Servicing, LP
8 fka Countrywide Home Loans Servicing, LP (**BANA**), and defendants Diana Hall and Daniel Hall
9 (the **Halls**) respectfully submit the following stipulation to allow BANA fourteen additional days to
10 oppose the Halls' motion to dismiss or for summary judgment [ECF No. 25].

11 The Halls filed their motion on August 28, 2017. BANA's deadline to file its opposition is
12 September 11, 2017. The parties stipulate to extending BANA's deadline by fourteen additional
13 days, to September 25, 2017, to allow BANA additional time to prepare its opposition. Good cause
14 exists to extend the deadline, as the extension will allow BANA's counsel to more fully review the
15 points and authorities raised in the motion.

1 This is BANA's first request for an extension of this deadline and is not intended for the
2 purposes of prejudice or delay.
