**STIPULATION AND ORDER FOR
PLAINTIFF TO EXTEND TIME TO
REPLY TO DEFENDANT'S
OPPOSITION TO PLAINTIFF'S
MOTION FOR LEAVE TO AMEND
AND FOR DEFENDANTS TO
RESPOND TO DISCOVERY**
(First Request)

19 Plaintiff, Clifford W. Miller, by and through counsel, Terri Keyser-Cooper, and Defendant
20 Romeo Aranas and the Nevada Department of Corrections, by and through counsel Aaron D. Ford,
21 Attorney General of the State of Nevada, and Douglas R. Rands, Senior Deputy Attorney General,
22 hereby stipulate and agree that the time for Plaintiff to file a Reply to Defendant's Opposition to
23 Plaintiff's Motion For Leave to Amend, ECF No. 61, shall be extended two weeks. The Reply is
24 currently due on April 6, 2020, the new deadline will be April 20, 2020. Defendants now have
25 outstanding discovery due to Plaintiff which is due on or about April 6th. The parties agree that
26 Defendants shall have up to and including April 20, 2020, to tender the discovery responses.

27 The purpose of the Stipulation is to allow the Plaintiff additional time as Plaintiff's counsel

1 has two emergency motions that require immediate attention and a brief in another case which is
2 approaching the statute of limitations. Due to these time restraints and unexpected filings by
3 opposing counsel in other cases, and counsels' schedule, it will not be possible for the parties to
4 meet the current deadlines. Therefore the parties stipulate and request that the date for Plaintiff to
5 file his Reply will be April 20, 2020 and the date for Defendant to respond to discovery will be
6 April 20, 2020. This stipulation is entered into in good faith.
