 22 Legal Title Trust IV ("Plaintiff" or "U.S. Bank"), Defendant, Thunder Properties, Inc.
 23 ("Thunder"), and Defendant, Highland Ranch Homeowners Association ("Highland Ranch")
 24 (collectively, the "Parties"), by and through their respective attorneys of record, hereby
 25 stipulate and agree as follows:

26 WHEREAS, on March 18, 2019, an Order Granting Stipulation and Order to Extend
 27 Deadline for Dispositive Motions to May 20, 2019 was filed [ECF No. 46];

1 WHEREAS, pursuant to the Stipulation and Order to Modify Discovery Plan and
2 Scheduling Order filed on November 27, 2018 [ECF No. 41], the deadline to file a Pretrial
3 Order is April 19, 2019; the deadline is suspended if dispositive motions are timely filed;

4 WHEREAS, the Parties continue to discuss global settlement, with reasonable
5 expectation that this matter will resolve without expending time and expense on further motion
6 practice;

7 THEREFORE, based on the above:

8 IT IS HEREBY STIPULATED AND AGREED that the deadline to file a Pretrial
9 Order should be continued from April 19, 2019 to June 19, 2019. The deadline is suspended if
10 dispositive motions are timely filed.

11 This is the Parties' first request for extension of the deadline to file a Pretrial Order.
12 This request is not intended to cause any delay or prejudice to any party.
