14	District Judge. The action was referred to the undersigned Magistrate Judge pursuant to 28 U.S.C. §	
15	636(b)(1)(B) and the Local Rules of Practice, LR 1B 1-4.	
16	Plaintiff filed an application to proceed in forma pauperis (IFP) and prose complaint on April 25,	
17	2017. (ECF Nos. 1, 1-1.) On June 29, 2017, the undersigned issued an order denying Plaintiff's IFP	
18	application without prejudice, and directing Plaintiff to file a new, complete application which clearly	
19	set forth the income and expenses within thirty days. (ECF No. 3.) The order was returned as	
20	undeliverable. (ECF No. 4.) To date, Plaintiff has neither provided an update address nor a completed	
21	IFP application. Therefore, the court recommends dismissal of this action without prejudice.	
22	RECOMMENDATION	
23	IT IS HEREBY RECOMMENDED that the District Judge enter an order <b>DISMISSING</b> this	
24	action WITHOUT PREJUDICE.	
25	Plaintiff should be aware of the following:	
26	1. Plaintiff may file, pursuant to 28 U.S.C. § 636(b)(1)(C), specific written objections to this	
27	Report and Recommendation within fourteen days of receipt. These objections should be titled	
28	"Objections to Magistrate Judge's Report and Recommendation" and should be accompanied by points	
	and authorities for consideration by the district	judge.
