**STIPULATION FOR EXTENSION OF TIME

BRIEF IN SUPPORT OF ITS MOTION TO  
AMEND ANSWER**

**(First Request)**

17 It is hereby **STIPULATED AND AGREED** between Plaintiff Robert M. Goggin ("Plaintiff")  
18 and Defendant Enterprise Leasing Company-West LLC ("Enterprise"), by and through their  
19 undersigned counsel, that Enterprise will have an additional week to file its reply in support of its  
20 motion to amend its answer to assert third-party claims ("Motion"), up to and including **November 28,**  
21 **2017.** This extension is requested as (i) the parties are currently discussing whether Plaintiff's  
22 opposition to the Motion will be withdrawn in light of the Court's recent granting of the parties'  
23 stipulation to extend the pre-trial and discovery deadlines and (ii) Enterprise seeks to avoid incurring  
24 additional costs and fees in drafting a potentially unnecessary brief.

25 Enterprise's Motion was filed on October 24, 2017 (ECF No. 49). Pursuant to a stipulation and  
26 order extending the time for Plaintiff's opposition, Plaintiff's opposition brief was filed on November  
27 14, 2017 (ECF No. 52), and Enterprise's reply brief is currently due on November 21, 2017. This is the

1 first request for an extension of time to file this reply brief, and it is filed in good faith and not for  
2 purposes of undue delay.


