**STIPULATION REGARDING  
 SETTLEMENT CONFERENCE  
 WITH MAGISTRATE JUDGE  
 VALERIE P. COOKE; AND  
 REQUEST FOR ORDER EXCUSING  
 CLIENT REPRESENTATIVES FROM  
 ATTENDING SAME**

1 Plaintiff Red Whale, LLC and defendant Blue Whale Coffee Company LLC  
2 (together, the "Parties"), by and through their undersigned counsel of record, hereby  
3 stipulate and agree to the entry in the above-captioned action (the "Action") of an order  
4 excusing client representatives from attending the Status Conference presently set for  
5 July 17, 2018 (*see* Dkt. No. 40), based on the following:

6 1. The Parties engaged in a Settlement Conference on November 6, 2017 and  
7 the Court entered Minutes of Settlement Conference entered on this same date (DE 35)  
8 (the "Settlement Order").

9 2. In compliance with the Settlement Order, the Parties submitted a Joint  
10 Status Report on February 15, 2018 (Dkt. No. 36) and a Second Joint Status Report on  
11 May 7, 2018 (Dkt. No. 39).

12 3. In addition, this Court conducted a telephonic conference with counsel for  
13 the Parties on March 5, 2018 regarding the First Joint Status Report (*see* Dkt. No. 38).

14 4. On June 22, 2018, this Court set a Status Conference for July 17, 2018 at  
15 2:00 p.m. and instructed that all Parties and their counsel are to attend the conference in-  
16 person (*see* Dkt. No. 40).

17 5. In the interim, counsel for Blue Whale sent an email to counsel for Red  
18 Whale on June 11, 2018, wherein Blue Whale reported that it "closing shop for good at  
19 the end of this month" and that "the doors will likely be closed for business before the . . .  
20 hearing date."

21 6. Insofar as Blue Whale is reporting that it is ceasing its business operations,  
22 and that counsel for Blue Whale will report on said status at the scheduled Status  
23 Conference on July 17, 2018, the Parties stipulate that client representatives for Red  
24 Whale and Blue Whale need not attend the Status Conference.


