13	I. DISCUSSION			
14	Plaintiff, who is a prisoner in the custody of the Nevada Department of Corrections, has			
15	Ibmitted a civil rights complaint pursuant to 42 U.S.C. § 1983 and has filed an application to			
16	proceed in forma pauperis. (ECF No. 1, 1-1).			
17	Plaintiff's application to proceed <i>in forma pauperis</i> is incomplete. Pursuant to 28 U.S.C.

19		5(a)(2) and Local Rule LSR 1-2, Plaintiff must complete an application to proceed <i>in pauperis</i> and attach both an inmate account statement for the past six months and a

21	properly executed financial certificate. Plaintiff has not completed pages 1 through 3 of his			
22	application to proceed <i>in forma pauperis</i> . (See ECF No. 1). As such, the <i>in forma pauperis</i>			
23		Court will retain Plaintiff's civil rights complaint		
24		er of the payment of the filing fee is resolved.		
25	Plaintiff will be granted an opportunity to cure t	he deficiencies of his application to proceed in		
26	forma pauperis, or in the alternative, pay the f	ull filing fee for this action. If Plaintiff chooses		
27	to file a new application to proceed in forma pauperis he must file a fully complete application

1	II. CONCLUSION	
2	For the foregoing reasons, IT IS ORDERED that Plaintiff's application to proceed in	
3	forma pauperis (ECF No. 1) is DENIED without prejudice to file a new application.	
4	IT IS FURTHER ORDERED that the Clerk of the Court SHALL SEND Plaintiff the	
5	approved form application to proceed in forma pauperis by a prisoner, as well as the document	
6	entitled information and instructions for filing an <i>in forma pauperis</i> application.	
7	IT IS FURTHER ORDERED that within thirty (30) days from the date of this order,	
8	Plaintiff shall either: (1) file a fully complete application to proceed <i>in forma pauperis</i> , on the	
9	correct form with complete financial attachments in compliance with 28 U.S.C. § 1915(a); or	
10	(2) pay the full \$400 fee for filing a civil action (which includes the \$350 filing fee and the \$50	
11	administrative fee).	
12	IT IS FURTHER ORDERED that if Plaintiff does not timely comply with this order,	
13	dismissal of this action may result.	
14	IT IS FURTHER ORDERED that the Clerk of the Court shall retain the complaint	
15	(ECF No. 1-1), but shall not file it at this time.
