13 On November 10, 2017 defendants TAHOE REGIONAL PLANNING AGENCY;
14 JOHN MARSHALL; BRIDGET CORNELL; JOANNE MARCHETTA; JIM BAETGE; JAMES
15 LAWRENCE; BILL YEATES; SHELLY ALDEAN; MARSHA BERKBIGLER; CASEY
16 BEYER; TIMOTHY CASHMAN; BELINDA FAUSTINOS; TIM CARLSON; AUSTIN SASS;
17 NANCY McDERMID; BARBARA CEGAVSKE; MARK BRUCE; SUE NOVASEL; LARRY
18 SEVASON and E. CLEMENT SHUTE, JR. (collectively, the "TRPA" defendants) filed their
19 motion to dismiss. (# 17). Defendants CROWN CASTLE and VERIZON WIRELESS, INC.
20 filed a joinder in the motion to dismiss on November 13, 2017. (# 23). Defendants
21 COMPLETE WIRELESS CONSULTING, INC. and MARIA KIM have an extension of time
22 to file their answer or responsive motion by November 30, 2017. (# 28). The plaintiff's
23 opposition to the motion to dismiss is currently due on November 24, 2017.

24 Given the scope and complexity of the legal issues presented in the motion to
25 dismiss, and the fact that the opposition is due the day after the Thanksgiving holiday, the
26 TRPA defendants, defendants COMPLETE WIRELESS CONSULTING, INC. and MARIA
27 KIM, and the plaintiff stipulate, under the authority of LR IA 6-1, that the plaintiff may have
28 to and including December 8, 2017 by which to file his opposition to the motion to dismiss.


