**JOINT STATUS REPORT AND  
REQUEST TO VACATE JANUARY 10,  
2019 CASE MANAGEMENT  
CONFERENCE**

18 Plaintiff Elizabeth Baker and Defendant Apttus Corporation, by and through their  
19 respective undersigned counsel, pursuant to the Court's Minute Order dated September 24, 2018  
20 (ECF No. 66), respectfully provide a status report and request to vacate the currently-scheduled  
21 January 10, 2019 case management conference.

22 The Minute Order states that further case management conferences are set for December  
23 12, 2018, and January 10, 2019, and the parties are to "file joint or separate case management  
24 reports by no later than four court days prior to each conference. If counsel determine that a  
25 conference is not necessary, counsel have leave to request that the conference be vacated." ECF  
26 No. 66. The parties previously requested that the December 12, 2018, conference be vacated  
27 because the parties scheduled private mediations.

28 The parties are currently continuing efforts to resolve this matter and have determined that

1 the January 10, 2019, case management conference is not necessary at this time. Accordingly, the  
2 parties respectfully request that the January 10, 2019 conference be vacated.
