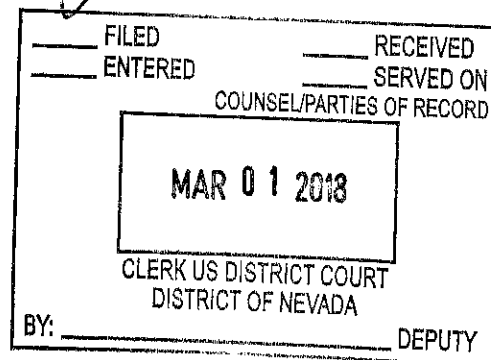

8 storm of the year is headed for the Reno, Nevada area this Thursday and Friday.


9 6. Because of the coming winter storm, the undersigned counsel is afraid that his travel will
