(ECF No. 1-1). 15 Plaintiff has neither paid the full filing fee for this matter nor filed an application to proceed in 16 forma pauperis. 17 Pursuant to 28 U.S.C. § 1915(a)(2) and Local Rule LSR 1-2, Plaintiff must complete an 18 application to proceed in forma pauperis and attach both an inmate account statement for the 19 past six months and a properly executed financial certificate. The Court will retain Plaintiff's 20 civil rights complaint (ECF No. 1-1), but will not file it until the matter of the payment of the 21 filing fee is resolved. Plaintiff will be granted an opportunity to file an application to proceed 22 in forma pauperis, or in the alternative, pay the full filing fee for this action. If Plaintiff chooses 23 to file an application to proceed in forma pauperis he must file a fully complete application to 24 proceed in forma pauperis. 25 CONCLUSION 26 For the foregoing reasons, IT IS ORDERED that the Clerk of the Court SHALL SEND 27 Plaintiff the approved form application to proceed in forma pauperis by a prisoner, as well as 28 the document entitled information and instructions for filing an in forma pauperis application.

IT IS FURTHER ORDERED that within **thirty (30) days** from the date of this order, Plaintiff shall either: (1) file a fully complete application to proceed *in forma pauperis*, on the correct form with complete financial attachments in compliance with 28 U.S.C. § 1915(a); or (2) pay the full \$400 fee for filing a civil action (which includes the \$350 filing fee and the \$50 administrative fee).

IT IS FURTHER ORDERED that if Plaintiff does not timely comply with this order, dismissal of this action may result.

IT IS FURTHER ORDERED that the Clerk of the Court shall retain the complaint (ECF No. 1-1), but shall not file it at this time.
