This is a *pro se* petition for writ of habeas corpus, pursuant to 28 U.S.C. § 2254, submitted by petitioner Teron Franklin (ECF No. 1-1). Franklin has also submitted an application to proceed *in forma pauperis*, but he has not included the required financial certificate or inmate account statements. Accordingly, this matter has not been properly commenced. 28 U.S.C. § 1915(a)(2); Local Rule LSR 1-2.

This action therefore is subject to dismissal without prejudice as improperly commenced. However, it appears from the papers presented that a dismissal without prejudice may materially affect a later analysis of any timeliness issue with regard to a new action.

Accordingly, petitioner shall have thirty (30) days to either (1) pay the \$5.00 filing fee or (2) submit a financial certificate completed and signed by an authorized officer and an inmate account statement for the past six months. Failure to do so may result in the dismissal of this action without prejudice.
